# 1 Introduction

These are upgrade notes for the docoll system.

There is an overview of the docoll system in related document "docoll system introduction".

## 2 0.7.4 to 0.7.5

### 2.1 Windows rsync clients

In `docoll_cwrsync.ini`, remove any folder path from the Files-from and Exclude-from values. The 0.7.6 script looks in the `cwRsync/docoll/conf` folder for these files.

The 0.7.5 script folds the local computer name to upper case. If your rsync server is configured with mixed or lower case client names, either:

- On the client, edit `docoll_cwrsync.ini` and use the Client-name keyword to set the name configured on the server

or

- On the server, change the clients' names to upper case in:
  - File `/etc/rsynd.secrets`
  - File `/etc/rsyncd.conf`
  - Directory names `/srv/rsync/docoll/<instance name>/<computer name>`.

## 3 0.7.5 to 0.7.6

### 3.1 GNU/Linux rsync clients

The directory structure for 0.7.6 has been revised to harmonise with the docoll server software conventions.

To upgrade, as root:

1. Remove the old installation's cron job:  
**rm /etc/cron.d/rsync\_script**
2. Do a new installation and customise the new configuration files based on the old ones (in the `/etc/opt/rsync_script` directory).

When the 0.7.6 GNU/Linux rsync client has tested OK, remove the earlier version by:

```
rm -fr /etc/opt/rsync_script /opt/rsync_script /var/opt/rsync_script/
```

## 3.2 Windows rsync clients

The default archive directory has been changed from "dd-Mmm-yyyy@hh-mm-ss" to "\_Changed and deleted files\yyyy\Mmm\dd\hh-mm". The change is intended to provide a more usable user interface when browsing.

The old behaviour can be preserved by using the docoll\_cwrsync.ini file's new keyword "Archive-folder", setting it to %n%- %b%- %Y%@%H%- %M%- %S%

A script to move the old name archive directories to the new name is available on request.

## 3.3 Collating and indexing

### 3.3.1 Creating a 0.7.6 test instance using the default instance's source files

This procedure assumes the current working directory has the docoll\_server-0.7.6.tgz file and that any previous test instance has been removed (procedure in docoll sysadmin guide):

version=0.7.6; instance=test; \
tar -xvzf docoll_server-$version.tgz --directory / \
&& ln -s /opt/docoll/$version/bin /opt/docoll/$instance \
&& mkdir -p \
    /etc/opt/docoll/$instance \
    /srv/docoll/$instance \
    /srv/rsync/docoll/$instance \
    /var/log/docoll/$instance \
    /var/opt/docoll/$instance/{backup,sources,tmp,xapian_db} \
    /var/www/docoll/$instance \
&& ln -s /srv/docoll/$instance /var/www/docoll/$instance/hits \
&& cd /var/opt/docoll/$instance/xapian_db \
&& ln -s . $instance \
&& createdb --owner docoll docoll_$instance \
&& cd /opt/docoll/$version/samples \
&& cp -p -R *.cfg omega.conf templates /etc/opt/docoll/$instance \
&& cd /etc/opt/docoll/$instance \
&& sed -i "s/%instance%/$instance/" \
    collate.cfg omega.conf omindex.sh.cfg run_scripts.cfg templates/inc/instance_cfg
```

Edit the /etc/opt/docoll/\$instance files as required, probably:

1. collate.cfg:
  - Set Postgres user docoll's password.
  - Change SourceRootDirs from test to default.
  - Change LeadingDirsToStrip to match change to SourceRootDirs.
2. run\_scripts.cfg: set up log mailing

## 0. PREAMBLE

The purpose of this License is to make a manual, textbook, or other functional and useful document "free" in the sense of freedom: to assure everyone the effective freedom to copy and redistribute it, with or without modifying it, either commercially or noncommercially. Secondly, this License preserves for the author and publisher a way to get credit for their work, while not being considered responsible for modifications made by others.

This License is a kind of "copyleft", which means that derivative works of the document must themselves be free in the same sense. It complements the GNU General Public License, which is a copyleft license designed for free software.

We have designed this License in order to use it for manuals for free software, because free software needs free documentation: a free program should come with manuals providing the same freedoms that the software does. But this License is not limited to software manuals; it can be used for any textual work, regardless of subject matter or whether it is published as a printed book. We recommend this License principally for works whose purpose is instruction or reference.

## 1. APPLICABILITY AND DEFINITIONS

This License applies to any manual or other work, in any medium, that contains a notice placed by the copyright holder saying it can be distributed under the terms of this License. Such a notice grants a world-wide, royalty-free license, unlimited in duration, to use that work under the conditions stated herein. The "Document", below, refers to any such manual or work. Any member of the public is a licensee, and is addressed as "you". You accept the license if you copy, modify or distribute the work in a way requiring permission under copyright law.

A "Modified Version" of the Document means any work containing the Document or a portion of it, either copied verbatim, or with modifications and/or translated into another language.

A "Secondary Section" is a named appendix or a front-matter section of the Document that deals exclusively with the relationship of the publishers or authors of the Document to the Document's overall subject (or to related matters) and contains nothing that could fall directly within that overall subject. (Thus, if the Document is in part a textbook of mathematics, a Secondary Section may not explain any mathematics.) The relationship could be a matter of historical connection with the subject or with related matters, or of legal, commercial, philosophical, ethical or political position regarding them.

The "Invariant Sections" are certain Secondary Sections whose titles are designated, as being those of Invariant Sections, in the notice that says that the Document is released under this License. If a section does not fit the above definition of Secondary then it is not allowed to be designated as Invariant. The Document may contain zero Invariant Sections. If the Document does not identify any Invariant Sections then there are none.

For works in formats which do not have any title page as such, "Title Page" means the text near the most prominent appearance of the work's title, preceding the beginning of the body of the text.

The "publisher" means any person or entity that distributes copies of the Document to the public.

If the Modified Version includes new front-matter sections or appendices that qualify as Secondary Sections and contain no material copied from the Document, you may at your option designate some or all of these sections as invariant.
